- * It makes our elections less secure by reducing transparency.
- * It fails to allow hand counting of ballots as proclaimed by our President and We the People.
- * It fails to prevent non-citizens from registering to vote or systematically removing them as ordered by our President and We the People declare.
- * It fails to protect vote-by-mail ballots and limit their use to those who cannot physically go to the polls as our President and We the People declare as imperative.
