Things are moving at lightening speed in Tallahassee. We got two of our bills filed, sent to committee and are crossing our fingers while waiting to see if they get passed through to the floor.

Here's the lineup of our bills, their companion bills, and their sponsors.

Elections and State Issued Identification (Only Citizens Vote):

- HB831 Jacques and Tremont
- SB1330 Garcia

#### Elections/Audits (VBM):

- HB1203 Barnaby
- SB396 Garcia

Election Technology Security (Tech Bill):

• SB394 – Garcia

As you can see, there is no House sponsor for SB394. There is a hail Mary move but we need your help. #### ALL GAS, NO BRAKES

Senator Ingoglia has introduced a stinker of an election bill, SB1414, that must be killed. When asked about his bill, he claimed it came from the Governor and the Secretary of State, Cord Byrd. Truth or not, it's going to be a big lift for us to convince legislators to go against a bill the Governor supposedly wants.

Ingoglia's bill has a lot of poison pills in it. A major one is that during reconciliation, the bill demands that ballot images be used in a recount and prohibits hand counting paper ballots.

This is how the 2020 Georgia election was stolen. Ballot images make it easier to cheat. In Georgia, evidence proved that ballot images were duplicated two and three times and added to the ballot totals. This was possible because digital images were used and not paper ballots. They could even change which bubble was filled in to make a Republican ballot appear to vote Democrat. SB364 is for the people of Florida. SB 1414 is for the machine vendors who will cash in on this legislation.

#### SOS FROM THE SOEs



Supervisors of Elections (SOEs) are required by law to submit an Election Security Plan each year to the state. Evidently, this hasn't been done for years. At a recent meeting they asked for help with a Model Election Security Plan. There are a lot of new SOEs this year and they need help getting up to speed. They asked. We delivered.

Deb Monks and her team put together a detailed plan for the SOEs. Here's where you come in. We are requesting that you make copies of the plan and give it to your SOE. There is also a script and follow up email to guide you when you meet with your SOE. This will create an opening for a relationship with your SOE. Even if your SOE isn't a newbie, there's a lot of information in the packet regarding new election legislation and rules. Email Deb at <u>sdmonks@proton.me</u> to get a copy. Print the first 133 pages and give it to your SOE. HINT: If you print it at home, Staples will bind it for less than \$10. Staples suggested using 24 weight paper for a professional presentation.

David Ramba holds a tremendous amount of power as the Executive Director of the Florida Supervisors of Elections (FSEs) and the boss of the Chairman of the RPOF, Evan Power.
