### TALLAHASSEE UPDATE



Defend Florida Volunteers from around the state met in Tallahassee the week of March 10<sup>th</sup> to advocate for Defend Florida's bills. Their work is not done, and neither is yours. We need <u>everyone</u> to call, email and write Florida's state legislators, especially their own, to advocate for our bills. We learned that the legislators keep track of the number of emails, calls etc. relating to different bills. It is imperative that Tallahassee legislators get inundated with calls promoting our bills and their sponsors while pointing out the shortcomings in the others like Senator Ingoglia's HB1414 and its companion bill sponsored by Jenna Persons-Mulicka, SB1381.

Each time we visit Tallahassee we learn something. This year, thinking we were ahead of the game as far as writing our bills and getting sponsors etc., we learned that we need to be there in June and July when the legislators are writing their bills. As one Defend team member put it, "I don't want to learn any more lessons. I want to get it right." So, guess what Defend Ambassadors, we're going to Tallahassee this summer.

### **MEETINGS WITH LEGISLATORS**

We had many productive meetings with legislators and garnered meetings with leadership that we didn't expect. One was with Senate Majority Leader Jim Boyd and the other was with Representative Will Robinson, House WIP and Chair of the State Affairs Committee. Both are key to getting our bills heard and passed. Each legislator we met with received a thank you package of cookies and a one-page flier regarding our bills. Smaller packages were given to their legislative aides as they are the important gate keepers that schedule meetings.

# **DEFENDER OF FLORIDA AWARDS**

Defend Florida gave Defender of Florida certificates to the following legislators.

- Representative Webster Barnaby for sponsoring HB1203 - Vote by Mail Security
- Representative Berny Jacques for sponsoring HB831 Only US Citizens Vote
- Representative Chase Tremont for cosponsoring HB831
- Senator Ileana Garcia for sponsoring three of our bills
  - o SB396 Vote by Mail Security
  - SB1330 Only US Citizens Vote
  - SB394 Technical Security

Make sure you thank these legislators for the kind attention they gave us and for sponsoring our bills.

Here are action steps that ensure your emails get the attention they deserve.

- 1. If you are contacting a House member, only mention the House bills. Dittos for the Senate.
- 2. Send your email noting the date and time you sent it.
- 3. Follow up with a phone call. Tell the legislative aide the date and time it was sent and ask them to print your email and put it on the legislator's desk.

This greatly increases the odds of your emails getting read by the legislator.

### **TALKING POINTS**

There are four main points to stress when comparing Senator Ingoglia's HB1414 and its companion bill SB1381 put forward by Representative Persons-Mulicka. Both bills have their good points but there are some poison pills that can't be ignored.

- HB1414/SB1381 removes the ability for a Supervisor of Elections to hand count paper ballots in a close election where a recount is generated. They are compelled to only use machine generated ballot images. Evidence shows that this is how the 2020 Georgia election was stolen. Ballot images were duplicated and, in some cases, ballot 'bubbles' altered from a Republican bubble to a Democrat one. HB1414 makes it illegal to reconcile the images with the paper ballots to prove there are fewer paper ballots than computer images.
- 2. PRRs (Public Record Requests) concerning election artifacts, like ballots, will no longer be available. The bill reclassifies those public records to critical election infrastructure. PRRs asking for this information will be rejected. It will be illegal for SOEs to access paper ballot information.
- 3. The bill is vendor friendly because it compels SOEs to purchase expensive election machinery called Clear Ballot. This will be a burden on smaller counties that could easily hand count ballots in a recount. We were assured by some legislators that the state will pick up the tab for the machines. This is not a good solution from the taxpayer's perspective because, when they say state, that means you and me.
- 4. HB1414/SB1381 does not prevent noncitizens, the deceased or people that moved out of state from voting in our elections.
