

HOW TO WAIVE IN OPPOSITION TO AN AMENDMENT REMOTELY
COMPLETE ASAP AND BEFORE NOON APRIL 1ST

- Go to www.flhouse.gov
- In the 2nd box in the dark banner at the top of the page, fill in the bill#...**1381**. Do not click “Enter” on your keyboard.
- Scroll over two boxes to the right and click **SEARCH**.
- Click the dark box on the right-hand side, **APPEAR AT MEETING**. (You must do this even though you won’t be there in person.)
- Complete **ATTENDEE INFORMATION** form with your personal information. In the last box where it says **REPRESENTING**, put Citizens, myself or Florida Citizens.
- Make sure the **MEETING TO ATTEND** says **Government Operations Subcommittee Apr. 1, 2025 4:00PM**.
- From the drop down menu to the right of **Select Agenda Item**, select **HB1381:Elections**.
- Next to **Add Appearance**, select **AMENDMENT**.
- In the empty box to the right of the word **AMENDMENT**, click on the down arrow to show the Amendment numbers.
- Click on 157595.
- Next to “**BILL**” click **OPPONENT**.
- Next to **AMENDMENT**, click **OPPONENT**.
- Click **ADD**.
- Click **AMENDMENT** again.
- Repeat previous action by clicking on the down arrow to show amendments.
- This time, choose 245541.
- Next to “**Bill**”, click **OPPONENT**.
- Next to “**Amendment**”, click **OPPONENT**.
- **DO NOT CLICK “ADD” OR ON TRASH CAN ICON**. (Clicking on the trash can icon will erase all of your information.)
- Click **I’M NOT A ROBOT**.
- Click **SUBMIT-PRINT**.
- Click **SUBMIT WRITTEN TESTIMONY**.
- Under the *Testimony bar, “**Select Agenda Item**” by clicking on the down arrow to the right.
- Scroll down to **HB1381: Elections**.
- Write your testimony.
- **IMPORTANT:** Click on the long dark box below your message that says **ADD**.
- Click **I’M NOT A ROBOT**.
- Click **SEND WRITTEN TESTIMONY** in the red box.
- Check your email for a copy of your testimony.

Here's a talking points cheat sheet for those that have trouble maneuvering the web.

*It makes our elections less secure by replacing manual audits with machine "vote validation" and "recounts" with "reviews" of digital ballots (images).

* "Vote validation" and "reviews" are undefined and purposely vague.

* It makes our elections less secure by reducing transparency.

* It fails to allow hand counting of ballots as our President and We the People are calling for.

* It fails to systematically remove non-citizens from our voter roll and prosecute violators as our President and We the People are calling for. [AMENDED HB1381 adds good measures for verifying that new voter registration applicants are U. S. citizens, but the ORIGINAL FILED HB1381 did not]

* It fails to protect vote-by-mail ballots and limit their use to those who cannot physically go to the polls as our President and We the People are calling for.

* It fails to update our laws to ensure the Enterprise Class technologies now used in our election process are secure.
